#### 1. Call to order and roll call.

The meeting was called to order at 4:33pm.

Commissioners: Adams, Dickerson, Dooley, Huie, Laguana, Ortiz-Cartagena, and Zouzounis were present. Staff in attendance: Dominica Donovan (Senior Policy Analyst).

## 2. Introduction of New Commissioner - Lawanda Dickerson. (Discussion Item).

Commissioner Laguana introduced Commissioner Dickerson.

Commission Dickerson expressed thanks for joining the Commission and shared her goals for her tenure.

### 3. Presentation: 13 Fund. (Discussion Item).

Bilal Mahmood and Jason Shen, Founders of the 13Fund presented on their organization for the Commission.

The Commission engaged in a substantive discussion with the presenters and requested additional information regarding the 13Fund's findings regarding commercial rent debt. They also discussed how relief efforts for restaurants specifically, and how improvements for distributing aid are needed, particularly in determining who the needlest actors are. The presenters concurred and shared that a goal for distributing relief should to ensure that dollars are distributed in a way that has the highest impact. The Commissioners emphasized equity in aid distribution and how that must be prioritized. The Commission encouraged the presenters to continue their discussions with

# 7. Office of Small Business Budget – FY 2021/2022. Second update and report on proposed budget for the Office of Small Business. (Discussion and Action Item)

Director Dick-Endrizzi presented on the Office of Small Business Budget – FY 2021/2022 and prosed budgetary adjustmetns. Director Dick-Endrizzi shared that proposed budget cuts would be from the Legacy Business Grant Program and office overhead costs.

With respect to budget enhancements, due to year over year increased demand for services- the Commission discussed needed budget enhancements with respect to additional staff, 1 Commission Secretary, 2 Business Assistance Counselors.

The Commission then discussed the Legacy Busness Program and Disability Access Fund budget and administration.

#### 8. Small Business Commission President's Outlook – 2021. (Discussion Item.)

Commission Laguana presented his outlook for SBC work for 2021. He highlighted the following:

- Receiving additional economic presentations;
- Being proactive with budgetary requests that support small business;
- Utilizing the survey administered in partnership with SF State to make informed policy recommendations;
- Advocating for Shared Spaces;
- Administering and providing oversight of the SF Venue Recovery Fund;
- Work related to the sub-committee on Racial Equity;
- Transportation, Travel and Tourism and Economic Development;
- Downtown economic stimulus; and,
- Stimulating other areas of commerce, like bio-tech.

The Commissioners discussed those issue areas and emphasized street cleanliness, assistance for Community Benefit Districts and business associations. They also emphasized approaching the topic areas through an equity lense. They emphasized that this is an opportunity to reenvision the City, and that there is significant value in fostering community around these issues.

### 11. Director's Report. (Discussion Item)

Director Dick-Endrizzi acknowleged the appointmen of Joaquin Torres to be Assessor Recorder and that Anne Taupier would be acting Director of OEWD. She also provided an update to the Commissin with respect to client services, the SBC Racial Equity Sub-Committee, and legislative updates.

#### 12. Commissioner Discussion and New Business. (Discussion Item)

Commissiner Zouzounis shared that SBA will be facilitating a number of small business training sessions for applying for PPP loans and EIDL assistance.

Commissioner Huie shared that she recently received a presentation on the administration of the San Francisco Street Crisis team. She also acknowleged that anti-Asian attacks have been increasing significantly sincer the beginning of the pandemic, particularly against Asian elders. And, that members of the Asian community, particularly seniors do not feel safe. Anti-Asian sentiment has severely impacted predominantly Asian corridors, especially Chinatown.

Commissioner Laguana empahasized that public safety should be prioritized by the Commission.

Commissiner Ortiz-Cartagena shared that today was the final day for the California Relief Grant, to his knowledge, not many minority and women owned businesses in San Francisco were able to obtain the grant. Commission Laguana shared additional data points on this. Commissioner Ortiz-Cartagena also shared that small landords need additional support, and new businesses that were incorporated at the start of the pandemic need additional relief.
