BUSINESS DESCRIPTION

San Sun Restaurant is a Southeast Asian sit-down restaurant, first opened by Vietnamese immigrant Xuong Sheh in 1990 at 941 Stockton Street. First arriving to the United States in 1979, Sheh worked in restaurants for 11 years to save money to buy a restaurant of his own. With his savings and the help of his family, Sheh was able to purchase the former May Garden restaurant on Stockton Street in 1990. Since opening 31 years ago, San Sun Restaurant has served a variety of authentic cuisine from several countries in the Southeast Asia region, including traditional dishes from Vietnam, Malaysia, Singapore, and the Teochew region of southern China, for dine-in. San Sun Restaurant's menu consistently offers various soup noodle (Pho), rice, vegetable, and meat dishes, infusing a modern take on original dishes with an emphasis on fresh ingredients. San Sun Restaurant has been family-owned and operated by the Sheh family since opening in 1990.

In 2011, San Sun Restaurant was forced to relocate due to the Central Subway project. The business stayed within Chinatown, moving to 848 Washington Street, where it has remained since.

Distinctive features of the restaurant include its white awning and matching exterior sign featuring San Sun's logo and writing in Vietnamese, Chinese, and English, and ground floor location in one of Chinatown's typical low-scale brick buildings. San Sun Restaurant's main dining area features a mix of two- and four-person table seating and circular banquet-style tables.

San Sun Restaurant has been a culinary staple and gathering spot in Chinatown throughout its 31-year history, serving local patrons and tourists of all ages its menu of Vietnamese, Malaysian, Singaporean, and Teochew dishes at a reasonable price. San Sun Restaurant has also served patrons of cultural significance, including entertainers well-known and popular in Asia such as Emil Chau and Wong Cho-Lam. San Sun Restaurant has continuously given back to the Chinatown community, most notably raising a significant amount of money for the construction of the new Chinese Hospital between 2011 and 2012. San Sun Restaurant has continuously donated gift cards, food, and coupons to other Chinatown-local charities throughout its existence. It has donated money, food, and hosted events for Gordon J. Lau Elementary School, the Tse Family Association, which funds school programs and scholarships for immigrants, the Community Youth Center of San Francisco, and the Chinatown Community Development Center. Lastly, San Sun Restaurant has been a consistent employer in Chinatown of at least a dozen staff, who are primarily from low-income families.

CRITERION 1

Yes, San Sun Restaurant has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years:

941 Stockton Street from 1990 to 2011 (21 years) 848 Washington Street from 2011 to Present (10 years)

CRITERION 2

Has the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community?

Yes, San Sun Restaurant has contributed to the history and identity of the Chinatown neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- The business is associated with traditional cuisine from Vietnam, Malaysia, Singapore, and the Teochew region of southern China.
- The business' primary location, located at 848 Washington Street, is in a three-story brick masonry Category A (History Resource Present) mixed-use building. The subject property has been determined a potential contributor located within the eligible National Register and eligible California Register Chinatown Historic District and is a contributory building to both. 848 Washington Street was included in the Chinatown Historic Survey (1994), where it received a California Historical Resource status code of "3D" (Appears eligible for NR as a contributor to a NR eligible district through survey evaluation). The subject property was also included in the Foundation For San Francisco Architectural Heritage Historic Survey (1978) and was determined to be of contextual importance to Chinatown.

Previous Planning Department review has described Chinatown and the immediate area surrounding the subject building to have been "constructed shortly after the earthquake with construction dates ranging to the late 1920s with a period of significance from 1906 to 1930. Due to the brief period of reconstruction after the 1906 Earthquake and Fire, the architectural styles of the vicinity are consistently Chinese Exotic Revival masonry structures — an eclectic, exoticized style established by prominent Anglo-American architects to mark the area as a tourist destination. Buildings range from two- to four-story mixed-use buildings constructed between 1906 and 1930, with occasional high-rise properties constructed in the post-WWII era." (Historic Resource Evaluation Response Case No. 2016-015777ENV). 848 Washington Street is also associated with the history of Chinese Hospital, an important community institution in Chinatown. In 1925, the building that presently houses San Sun Restaurant was donated to the Chinese Hospital by a well-to-do Hong Kong businessman to help with the hospital's collective fundraising effort.

 There have been a number of local features, articles, and television news stories on San Sun Restaurant. The restaurant has been covered in local media, including articles in the San Francisco Chronicle. San Sun Restaurant has also been featured in Hong Kong-based Sing Tao Daily. San Sun Restaurant has also been featured in Chowhound, a national online resource for food enthusiasts.

CRITERION 3

Is the applicant committed to maintaining the physical features or traditions that define the business, including craft, culinary, or art forms?





Yes, San Sun Restaurant is committed to maintaining the physical features and traditions that define the business.

SAN SUN RESTAURANT Section 4: Written Historical Narrative

CRITERION 1

Provide a short history of the business from the date the business opened in San Francisco to the present day, including the ownership history. For businesses with multiple locations, include the history of the original location in San Francisco (including whether it was the business's founding and or headquartered location) and the opening dates and locations of all other locations.

San Sun Restaurant, currently located at 848 Washington Street in San Francisco's Chinatown, was established by Xuong Sheh on September 4, 1990. The Asian restaurant is known for its modern interpretation of classic dishes and its insistence on only using high-quality, fresh ingredients.

Xuong Sheh and his family were boat people from Vietnam. They arrived in Alabama in 1979 and shortly thereafter moved to California in 1980. For the next 10 years, Mr. Sheh worked in a restaurant in Los Angeles and saved his money. With the help of his family, he was able to borrow money in order to purchase one of the first Vietnamese restaurants in San Francisco. In September of 1990, the Xuong Sheh family bought the May Garden restaurant and changed its name to San Sun Restaurant. San stands for San Francisco, and Sun represents the three male members within the family household. To this day, Xuong and his son James Sheh still work in the restaurant.

The original location of San Sun Restaurant was 941 Stockton Street in the heart of Chinatown. Their main offering at the time was an Asian-style noodle soup or what we know as Pho. The restaurant expanded its menu to include Southeast Asian style food including Malaysian and Singaporean, as well as Chinese food from the Teochew region of China. The restaurant thrived at this location.

Twenty-one years later in 2011, Mr. Sheh had to move his restaurant because the land was needed for the upcoming Central Subway Project. Eminent domain forced all of the businesses on that section of Stockton Street to move. Mr. Sheh was among the first to make the move to 848 Washington Street on June 17, 2011. Other retailers and restaurants followed his lead and moved as well. Mr. Sheh purchased the building that housed his new location with the assistance of a Small Business Association loan.

In many ways, the forced relocation to Washington Street was a godsend because the new space was larger and allowed for more seating capacity, increasing from 40 to 90 people. The move also required new décor, which customers love.

b. Describe any circumstances that required the business to cease operations in San Francisco for more than six months?

The restaurant was closed for only one week during the move from Stockton Street to Washington Street.

More recently, the restaurant had to close due to the governor's shelter-in-place mandate during the coronavirus pandemic. The restaurant closed for six months from March 17, 2020 through August 31, 2020. They reopened on September 1, 2020.

c. Is the business a family-owned business? If so, give the generational history of the business.

Xuong Sheh has owned San Sun Restaurant since it was established in 1990. Xuong Sheh has two sons, one of whom works with him in the business. James Sheh was in college at the time his father purchased the restaurant. He is now managing the restaurant, and Xuong comes in occasionally and helps out.

d. Describe the ownership history when the business ownership is not the original owner or a family-owned business.

The ownership history of San Sun Restaurant is as follows:

1990 to Present Xuong Sheh

e. When the current ownership is not the original owner and has owned the business for less than 30 years, the applicant will need to provide documentation of the existence of the business prior to current ownership to verify it has been in operation for 30+ years. Documentation of the existence of the business verifying it has been in operation since September 17, 1990, per the Department of Public Health.

f. Note any other special features of the business location, such as, if the property associated with the business is listed on a local, state, or federal historic resources registry.

The historic resource status of the building of the building that houses San Sun Restaurant is classified by the Planning Department as Category A, Historic Resource Present, with regard to the California Environmental Quality Act. In a 1978 survey by the Foundation For San Francisco Architectural Heritage, the building was determined to be of "contextual importance." In a Chinatown survey in 1994, the building was determined to be "contributory" to the Chinatown Historic District. The building appears to be eligible for the National Register, through survey evaluation in 1997, as a contributor to the National Register-eligible Chinatown Historic District.

CRITERION 2

a. Describe the business's contribution to the history and/or identity of the neighborhood, community or San Francisco.

San Sun Restaurant is an Asian restaurant known for its modern interpretation of classic dishes and its insistence on only using high-quality, fresh ingredients. San Sun offers an extensive variety of cuisines in a comfortable setting at reasonable prices, including Vietnamese,

Malaysian, Singaporean, and Chinese. San Sun is a cornerstone in the San Francisco community and has been recognized for its outstanding food, excellent service, and friendly staff.

b. Is the business (or has been) associated with significant events in the neighborhood, the city, or the business industry?

San Sun restaurant has contributed to significant events and developments in Chinatown, including a fundraising effort to help pay for the construction of the Chinese Hospital located at 845 Jackson Street and donations for community gatherings that help bring the community together.

The business owner has shown leadership when mandated by the City and County of San Francisco to move his business because of the Central Subway project. San Sun Restaurant was the first commercial business in the building to accept the mandate and find a new location, moving from Stockton Street to Washington Street. He encouraged the other businesses not to resist the forced change and move as well. For most, it was a change for the better.

c. Has the business ever been referenced in an historical context? Such as in a business trade publication, media, or historical documents?

San Sun Restaurant was featured in an article by Jonathan Kauffman in the San Francisco Chronicle on February 1, 2019, titled, "The best meals in Chinatown for under \$20":

"Every corner of [the San Sun Restaurant shines], from the gold columns and mirrored walls to the silvery bowls, cups and chopsticks. Its spiral-bound menu resembles an encyclopedia of Vietnamese noodle soups: beef pho and hu tieu, multiple combinations of meatballs, pork kidney noodles, and noodles with a saday-sauce broth. All are available with your choice of a half-dozen noodle shapes. It seems almost perverse to recommend two of the simpler soups based on chicken stock. Yet the broth is so clear, so present, that the soup doesn't need much more than a bit of shredded meat, toasted shallots and scallions, in the pho ga, or thin-skinned chicken-leek dumplings whose filling is dominated by aromatics."

d. Is the business associated with a significant or historical person?

Over the years, there are many celebrities that have visited the restaurant, including singers and movie stars. There are two well-known Chinese actors that have dined at the restaurant. Emil Chau is a Hong Kong born Taiwanese singer, songwriter and actor known throughout Taiwan, mainland China, Hong Kong, and Southeast Asia. Wong Cho-lam is a Hong Kong entertainer currently working for TVB who has done acting on television and stage. He is also the host of Hunan TV's World's Got Talent.

e. How does the business demonstrate its commitment to the community?

San Sun restaurant has participated in several charitable endeavors including a fundraising effort to help pay for the construction of the Chinese Hospital located at 845 Jackson Street. A donation of \$7,000 was made between 2011-2012. A *Sing Tao* newspaper story appeared in 2012 about the fundraising effort.

In March of 2012, the Sheh family donated \$880 to Gordon J. Lau that went towards providing free laptops for students.

Every year, San Sun also donates over \$1,000 to the San Francisco Tse Family Association to fund programs like scholarships for immigrants and community gatherings that help bring the community together.

Since 1990, San Sun Restaurant has always contributed to the various community charities that ask for help. They have supported the Community Youth Center of San Francisco and Chinatown Community Development Center events whenever asked. They donate gift cards, coupons, and food.

f. Provide a description of the community the business serves.

San Sun Restaurant's customers are residents not only of Chinatown but also the city at large. They are families, businesspeople, and tourists, young and old – anyone who enjoys good Southeast Asian and Chinese food. The restaurant is well known for its extensive offerings of reasonably priced noodle soups and entrees. Prices range from \$5.75 to under \$10 per entrée.

g. Is the business associated with a culturally significant building/structure/site/object/interior?

In 1925, the building that presently houses San Sun Restaurant at 848 Washington Street was donated to the Chinese Hospital by a well-to-do Hong Kong businessman to help with the hospital's collective fundraising effort. Chinese Hospital sold the building to a Chinese restaurant in the early 2000s, and James Sheh purchased the building from the previous owner in 2010. There is signage on the outside of the building that relays the story of the fundraising effort.

There is nothing in the restaurant itself that might be of special interest other than the photos of some well-known Chinese entertainers that customers would recognize.

h. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

Prior to the coronavirus pandemic in 2020-21, San Sun Restaurant employed 11 full-time workers, with the majority of them coming from low-income families. If the restaurant were to close it would greatly impact the livelihood of those 11 families. Although there are many restaurants in Chinatown, there are very few that have the extensive noodle soup selection that San Sun has. Their low-price points for delicious, authentic Southeast Asian food would be sorely missed by both regular customers and tourists alike. Generations of customers bring their growing families to the restaurant. For many it has become a family tradition to dine at San Sun — especially since they expanded their capacity and redecorated. It is also one of the few restaurants in Chinatown that is open late into the evening.

CRITERION 3

a. Describe the business and the essential features that define its character.

San Sun Restaurant offers an extensive variety of Southeast Asian and Chinese cuisine in a comfortable setting at reasonable prices. Their loyal customers return because the food is authentic and delicious. People who love Pho-type noodle soups frequent this restaurant because of the large selection of different soups offered. Their Teochew cuisine is very popular with those who favor Cantonese cuisine since it is similar in its style and technique.

b. How does the business demonstrate a commitment to maintaining the historical traditions that define the business, and which of these traditions should not be changed in order to retain the businesses historical character? (e.g., business model, goods and services, craft, culinary, or art forms)

James Sheh is committed to maintaining what his father originally created – a family-oriented restaurant with good authentic cuisine in a comfortable environment.

c. How has the business demonstrated a commitment to maintaining the special physical features that define the business? Describe any special exterior and interior physical characteristics of the space occupied by the business (e.g. signage, murals, architectural details, neon signs, etc.).

The business's signage has significance. It is in three languages – Chinese, Vietnamese, and English. The business' logo is depicted as a sun burst with three clouds. San in the name signifies San Francisco. Sun means "man" in Chinese. There are three men in the Sheh family, the father and his two sons. The three clouds in the logo represent the three men of the Sheh family.

d. When the current ownership is not the original owner and has owned the business for less than 30 years; the applicant will need to provide documentation that demonstrates the current owner has maintained the physical features or traditions that define the business, including craft, culinary, or art forms. Please use the list of supplemental documents and/or materials as a guide to help demonstrate the existence of the business prior to current ownership.

Documentation that demonstrates the business has been an Asian restaurant for 30+ years is included in this Legacy Business Registry application. The Sheh family are the original owners of San Sun, and the restaurant recently celebrated its 30th anniversary.







What: Pho ga or chicken-leek dumpling noodle (\$6.50 for a small)

When: 10 a.m.-8 p.m. Mon.-Sun. daily.

Every corner of San Sun gleams, from the gold columns and mirrored walls to the silvery bowls, cups and chopsticks. Its spiral-bound menu resembles an encyclopedia of Vietnamese noodle soups: beef pho and hu tieu, multiple combinations of meatballs, pork kidney noodles, and noodles with a saday-sauce broth. All are available with your choice of a half-dozen noodle shapes. It seems almost perverse to recommend two of the simpler soups based on chicken stock. Yet the broth is so clear, so present, that the soup doesn't need much more than a bit of shredded meat, toasted shallots and scallions, in the pho ga, or thin-skinned chicken-leek dumplings whose filling is dominated by aromatics.



Business Description

San Sun Restaurant is a Southeast Asian sit-down restaurant, first opened by Vietnamese immigrant Xuong Sheh in 1990 at 941 Stockton Street. First arriving to the United States in 1979, Sheh worked in restaurants for 11 years to save money to buy a restaurant of his own. With his savings and the help of his family, Sheh was able to purchase the former May Garden restaurant on Stockton Street in 1990. Since opening 31 years ago, San Sun Restaurant has served a variety of authentic cuisine from several countries in the Southeast Asia region, including traditional dishes from Vietnam, Malaysia, Singapore, and the Teochew region of southern China, for dine-in. San Sun Restaurant's menu consistently offers various soup noodle (Pho), rice, vegetable, and meat dishes, infusing a modern take on original dishes with an emphasis on fresh ingredients. San Sun Restaurant has been family-owned and operated by the Sheh family since opening in 1990.

San Sun Restaurant first opened in 1990 at 941 Stockton Street in Chinatown, where it remained until 2011, when it was forced to relocate due to the Central Subway project. San Sun Restaurant stayed within Chinatown, moving to 848 Washington Street, where it has remained since. Distinctive features of the restaurant include its

white awning and matching exterior sign featuring San Sun's logo and writing in Vietnamese, Chinese, and English, and ground floor location in one of Chinatown's typical low-scale brick buildings. San Sun Restaurant's main dining area features a mix of two and four-person table seating and circular banquet-style tables.

San Sun Restaurant has been a culinary staple and gathering spot in Chinatown throughout its 31-year history, serving local patrons and tourists of all ages its menu of Vietnamese, Malaysian, Singaporean, and Teochew dishes at a reasonable price. San Sun Restaurant has also served patrons of cultural significance, including entertainers well-known and popular in Asia such as Emil Chau and Wong Cho-Lam.

San Sun Restaurant has continuously given back to the Chinatown community, most notably raising a significant amount of money for the construction of the new Chinese Hospital between 2011 and 2012. San Sun Restaurant has continuously donated gift cards, food, and coupons to other Chinatown-local charities throughout its existence. It has donated money, food, and hosted events for Gordon J. Lau Elementary School, the Tse Family Association, which funds school programs and scholarships for immigrants, the Community Youth Center of San Francisco, and the Chinatown Community Development Center. Lastly, San Sun Restaurant has been a consistent employer in Chinatown of at least a dozen staff, who are primarily from low-income families.

The business's primary location, 848 Washington Street, is a Category A (Historic Resource Present) structure on the north side of Washington Street between Grant Avenue and Stockton Street in Chinatown. It is within the CRNC (Chinatown- Residential- Neighborhood Commercial) Zoning District and a 50-N Height and Bulk District. It is also within the Chinatown Planning Area and the Chinatown Mayor's Invest in Neighborhoods Initiative Area.

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1990.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. San Sun Restaurant qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. San Sun Restaurant has operated continuously in San Francisco for 31 years.
- b. San Sun Restaurant has contributed to the history and identity of the Chinatown neighborhood and San Francisco.
- c. San Sun Restaurant is committed to maintaining the physical features and traditions that define the organization.



3. Is the business associated with a culturally significant art/craft/cuisine/tradition?

Yes. The business is associated with traditional cuisine from Vietnam, Malaysia, Singapore, and the Teochew region of southern China.

4. Is the business or its building associated with significant events, persons, and/or architecture?

Yes. The Washington Street property is located within the eligible National Register and eligible California Register Chinatown Historic District. Previous Planning Department review has described Chinatown and the immediate area surrounding the subject building to have been "constructed shortly after the earthquake with construction dates ranging to the late 1920s with a period of significance from 1906 to 1930. Due to the brief period of reconstruction after the 1906 Earthquake and Fire, the architectural styles of the vicinity are consistently Chinese Exotic Revival masonry structures — an eclectic, exoticized style established by prominent Anglo-American architects to mark the area as a tourist destination. Buildings range from two- to four-story mixed-use buildings constructed between 1906 and 1930, with occasional high-rise properties constructed in the post-WWII era." (Historic Resource Evaluation Response Case No. 2016-015777ENV). 848 Washington Street is also associated with the history of Chinese Hospital, an important community institution in Chinatown. In 1925, the building that presently houses San Sun Restaurant was donated to the Chinese Hospital by a well-to-do Hong Kong businessman to help with the hospital's collective fundraising effort.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

Yes. The business' primary location, located at 848 Washington Street, is in a three-story brick masonry Category A (History Resource Present) mixed-use building. The subject property has been determined a potential contributor located within the eligible National Register and eligible California Register Chinatown Historic District and is a contributory building to both. 848 Washington Street was included in the Chinatown Historic Survey (1994), where it received a California Historical Resource status code of "3D" (Appears eligible for NR as a contributor to a NR eligible district through survey evaluation). The subject property was also included in the Foundation For San Francisco Architectural Heritage Historic Survey (1978) and was determined to be of contextual importance to Chinatown.

6. *Is the business mentioned in a local historic context statement?*

No, not as of the date of this Executive Summary.

7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. There have been a number of local features, articles, and television news stories on San Sun Restaurant.
