### BUSINESS DESCRIPTION

Dr. Kenneth Agues founded For Your Eyes Only Optometry ("FYEO") in 1983. Dr. Agues was an important source for trusted, compassionate eye care near the beginning of the AIDS crisis. Eye care was especially important to people with AIDS because, with their weakened immune systems, they were at high risk of Cytomegalovirus Retinitis, an aggressive eye infection that commonly led to blindness. Dr. Agues himself became sick from AIDS and passed away in 1992. Before his death, he found Dr. Kathleen Kennedy to take over the practice. Dr. Kennedy started seeing patients and running the practice at For Your Eyes Only under the mentorship of Dr. Agues., and she purchased it in 1991.

As the AIDS epidemic worsened, Dr. Kennedy and the For Your Eyes Only staff continued to provide outstanding care without stigma to people of the Castro, including many with AIDS. During the height of the AIDS crisis, FYEO was a respectful haven of comfort and care for those diagnosed with AIDS or HIV at a time when many doctors were refusing to treat those living with the ailment.

For Your Eyes Only Optometry stays current with the latest vision-related research and technology and provide high quality professional care in a warm and friendly environment. The business serves everyone, but it is notable that, in the early years, 90% of For Your Eyes Only's patients were gay men. Presently, 60% of patients identify as male and approximately 80% identify as LGBTQ. Most patients live or work in the Castro.

The business is located in the Castro neighborhood on Castro Street between 18th and 19th streets.

**CRITERION 2: Has the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community?**

Yes, the applicant has contributed to the Castro neighborhood's history and identity.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- For Your Eyes Only Optometry is associated with the craft of optometry.
- For Your Eyes Only Optometry has contributed to the history and identity of the Castro and San Francisco.
- The property is eligible for listing in the CA Register and has a Planning Department Historic Resource status of "A" (Known Historic Resource). The property is associated with the Castro Street Commercial Historic District, representing the development of the Eureka Valley neighborhood of San Francisco from a late 19th century streetcar suburb, through its height during the reconstruction period following the 1906 Earthquake and Fire, to the Great Depression of 1929 that marked the end of the first period of commercial development. The second wave of development in the district in the 1970s represents the consolidation of the LGBT community in San Francisco and its relocation to the Castro neighborhood. The Castro neighborhood is significant as the backdrop for the LGBT movement in San Francisco, which has exceptional significance as a cultural, social, and political local movement that later gained national attention with the first March on Washington in 1979. Contributors to the district include mixed-use commercial buildings dating from 1880-1929. The neighborhood today displays the architectural congruity necessary to qualify for listing under Criterion 1 for its early history as an early street car suburb in San Francisco and for its significance associated with the commercial development of Eureka Valley. The neighborhood also displays cultural significance associated with the LGBT movement in San Francisco such that it qualifies under Criterion 1 and National Register Consideration C for properties that have achieved significance in the past 50 years. The Castro is an important center of the San Francisco's LGBT movement in the 1970s, which became a national model for the struggle of the LGBT community for acceptance in the late 20th century.
- The Bay Area Reporter featured Dr. Agues' obituary in 1992, documenting his career and founding of For Your Eyes Only. Notes by Rick Le Blanc in 2009, Dr. Agues' former employee, provided more detail about the history of the practice and Dr. Kennedy's succession. Both of these documents can be found in the GLBT Historical Society archives.
- Business Name has received the following awards and/or commendations:
  - Dr. Kennedy was chosen for the Young Optometrist of the Year award by the California Optometric Association (1994), as well as 20/20 Magazine's Best and Brightest award (1993).
  - In 2006, the Lyon Martin Health Services' Brothers for Sisters campaign awarded Dr. Kennedy recognition for her contributions to the wellbeing of the LGBT community.
  - In 2015, Supervisor Scott Weiner presented Dr. Kennedy with a certificate of honor, and Senator Mark Leno presented Dr. Kennedy with a certificate of recognition for her 25 years at the practice.
  - For Your Eyes Only Optometry was recognized and congratulated in the June 2015 Castro Merchants' newsletter.



When Dr. Kenneth Agues founded For Your Eyes Only Optometry (“FYEO”) in 1983 at 552 Castro Street, he established the roots of a practice that has continuously served San Francisco’s unique Castro community for the past 35 years.

Dr. Agues was an important source for trusted, compassionate eye care near the beginning of the AIDS crisis. Eye care was especially important to people with AIDS because, with their weakened immune systems, they were at high risk of Cytomegalovirus Retinitis, an aggressive eye infection that commonly led to blindness. Then, sadly, Dr. Agues himself became sick from AIDS. He searched for another doctor to take over his practice and felt it was of utmost importance to find someone who would care for his patients with the same level of sincerity and thoroughness as he valued.

In 1990, Dr. Agues found Dr. Kathleen Kennedy. They shared the same level of commitment to excellent patient care. Dr. Kennedy started seeing patients and running the practice at For Your Eyes Only under the mentorship of Dr. Agues. He was a great advisor and offered much support to Dr. Kennedy during her early days in the practice, often having her over for dinner at his beautiful home on Beaver Street in the Castro. Dr. Kennedy purchased the practice in 1991. With the practice and his patients in Dr. Kennedy’s capable hands, Dr. Agues was able to relax and spend the end of his life enjoying the company of his family and friends. Dr. Agues died in January of 1992.

As the epidemic worsened, Dr. Kennedy and the For Your Eyes Only staff continued to provide outstanding care without stigma to people of the Castro, including many with AIDS. During the height of the AIDS crisis, FYEO was a respectful haven of comfort and care for those diagnosed with AIDS or HIV at a time when many doctors were refusing to treat those living with the ailment. The practice was not to be left untouched. In addition to Dr. Agues, many FYEO patients and staff members died as a result of AIDS. Fear and loss haunted the era. In that time of sorrow, For Your Eyes Only remained dedicated to providing a warm, professional, reliable source of eye care for all people.

After Dr. Agues’ passing, Dr. Kennedy did much to maintain the practice’s reputation for excellence in both the neighborhood and the optometric community. As the business grew, Dr.

Kennedy hired other outstanding optometrists, opticians and staff dedicated to providing professional and high quality service.

For Your Eyes Only Optometry has stood the test of time for over three decades. The business has worked hard to be worthy of patients' trust. They stay current with the latest vision-related research and technology and provide high quality professional care in a warm and friendly environment. For Your Eyes Only Optometry is proud to serve their community during its darkest and happiest times. Being designated a Legacy Business would significantly increase the chance of For Your Eyes Only Optometry's staying at 552 Castro Street so they can continue to serve the Castro for many years to come.

**b. Describe any circumstances that required the business to cease operations in San Francisco for more than six months?**

For Your Eyes Only Optometry has been operating continuously in the same location since 1983.

For Your Eyes Only Optometry has not been passed through generations of the same family; however, it is a single office private practice fully owned by Dr. Kennedy now and Dr. Agues before her.

The Bay Area Reporter featured Dr. Agues' obituary in 1992, documenting his career and founding of For Your Eyes Only. Notes by Rick Le Blanc in 2009, Dr. Agues' former employee, provided more detail about the history of the practice and Dr. Kennedy's succession. Both of these documents can be found in the GLBT Historical Society archives (copies of which are included in the Legacy Business Registry application).

Dr. Kennedy was chosen for the Young Optometrist of the Year award by the California Optometric Association (1994), as well as 20/20 Magazine's Best and Brightest award (1993).

In 2006, the Lyon Martin Health Services' Brothers for Sisters campaign awarded Dr. Kennedy recognition for her contributions to the wellbeing of the LGBT community.

In 2015, Supervisor Scott Weiner presented Dr. Kennedy with a certificate of honor, and Senator Mark Leno presented Dr. Kennedy with a certificate of recognition for her 25 years at the practice.

For Your Eyes Only Optometry was recognized and congratulated in the June 2015 Castro Merchants' newsletter.

**d. Is the business associated with a significant or historical person?**

For Your Eyes Only has and has had the honor of caring for many notable people in the LGBTQ community but due to HIPAA privacy laws they cannot be named.

**e. How does the business demonstrate its commitment to the community?**

For Your Eyes Only has always been a part of and has always supported the Castro community. The practice treats all of its patients with kindness and respect and has always welcomed all people regardless of gender identity, sexual orientation, race, ethnicity or any other traits. Dr. Kennedy and her staff, along with the whole neighborhood, were joyful when Gavin Newsom first allowed same sex marriages to be performed, were heartbroken when Proposition 8

passed in California and took to the streets in celebration after the Supreme Court decision to uphold same sex marriage. In Section 5, Photo 1 shows Dr. Kennedy celebrating on Castro Street on the eve of the Supreme Court decision. This same passion and energy is present in FYEO's daily patient interactions and dedication to their patients' care.

For Your Eyes Only has supported the community through excellent patient care and has contributed in other ways as well. Dr. Agues had sponsored a gay bowling league team. Photo 7 in Section 5 shows the bowling shirt of Ed Tubaugh, who was For Your Eyes Only's office manager in the 1980s and Dr. Agues' life partner.

Dr. Kennedy continued to contribute to the Castro community, for example as member of the Castro Lions Club. With the Castro Lions she helped raise money for the AIDS Emergency Fund and made donations to many other AIDS charities. She continues these donations to this day.

In 1990, Dr. Kennedy served as the Education Director of the San Francisco County Optometric Society and in 1991, the San Francisco Optometric Society elected Dr. Kennedy to serve as its president.

Throughout the years, For Your Eyes Only has also donated time, materials, and money to our community through organizations such as LYRIC, which serves San Francisco's LGBTQ youth; the GLBT Historical Society; W.O.M.A.N. Inc., which serves survivors of domestic violence in the Bay Area; Project Homeless Connect, where Dr. Kennedy and staff provide eye exams and glasses fittings; the Bay Area Legal Aid Society; and Lions In Sight, which collects donated glasses from patients to share across the world. The doctors have donated their time performing school vision screenings to Howell Mountain, Pope Mountain schools in Napa, San Francisco's Convent of the Sacred Heart schools and others in the Bay Area. In addition, Dr. Kennedy has volunteered her time on international clinic missions providing free eye care and glasses to people in need around the world. The practice has also supported others directly in the neighborhood, such as advertising in the Gay Men's Chorus programs and providing free eye exams and glasses for children at the Castro's neighborhood elementary school, Harvey Milk Civil Rights Academy.

The practice has a strong presence in the professional community also. For Your Eyes Only has long-standing memberships in the Castro Merchants' Association (previously known as MUMC); the Golden Gate Business Association; the San Francisco Optometric Society, where Dr. Kennedy is a past President; the California Optometric Society; and the American Optometric Society.

**f. Provide a description of the community the business serves.**

For Your Eyes Only Optometry's doors are open to all. In the early years, 90% of For Your Eyes Only's patients were gay men. Nowadays, 60% of patients identify as male and approximately 80% identify as LGBTQ. Most patients live or work in the Castro, although patients also hail from the surrounding Bay Area counties and beyond. One of the biggest compliments to the

practice is that patients who have moved away, sometimes very far away, will return year after year for their eye care. Patients of nearly every age are seen, starting with elementary school-aged children. While hundreds of new patients are seen every year, previous patients make up the bulk of the patient base, including some who have been with the office for 20 plus years, some even having been patients of Dr. Agues!

**g. Is the business associated with a culturally significant building/structure/site/object/interior?**

The building is a contributor to the Eligible Castro Street Historic District. It is classified by the Planning Department as "Historic Resource Present." There was a major renovation of the office suite in 2001. Dr. Kennedy expanded the practice space to more than twice its size while preserving the historic character of the building. The building is a Victorian dating back to at least the very beginning of the 20th century, a fact known because the building records were lost in the fire following the 1906 earthquake. Dr. Kennedy made sure to maintain or restore period details during the expansion, working closely with the contractor and architect on such elements as rounding wall corners, the crown molding designs, restoring the narrow width planks in the hardwood floors, and the door styles selected.

**h. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?**

The building where For Your Eyes Only has been continuously located for 35 years recently came under new ownership, and FYEO's lease will be up for renewal soon. Over the years, FYEO has seen big businesses take over many small merchants that once adorned the neighborhood. If FYEO loses its lease, thousands of people, most of whom identify as LGBTQ, would lose their trusted source of eye care and the Castro would lose yet another part of its neighborhood character and history.









3. *Is the business associated with a culturally significant art/craft/cuisine/tradition?*

Yes. The business is associated with the craft of optometry.

4. *Is the business or its building associated with significant events, persons, and/or architecture?*

Yes. The property is associated with the Castro Street Commercial Historic District, representing the development of the Eureka Valley neighborhood of San Francisco from a late 19th century streetcar suburb, through its height during the reconstruction period following the 1906 Earthquake and Fire, to the Great Depression of 1929 that marked the end of the first period of commercial development. The second wave of development in the district in the 1970s represents the consolidation of the LGBT community in San Francisco and its relocation to the Castro neighborhood.
