BUSINESS DESCRIPTION

The Delicate Daisy – House of Flowers is a retail flower and gift shop located at 6040 Geary Boulevard selling flowers, flower arrangements, and gift baskets. The Delicate Daisy – House of Flowers has roots in two different San Francisco flower shops: House of Flowers and The Delicate Daisy.

House of Flowers was founded in 1939 by Simon Israel in the Richmond neighborhood at 6040 Geary Boulevard, where is remains today. Simon's daughter Ruth and her husband Ron Miguel took over the business in 1966.

The Delicate Daisy was founded in 1982 by Roxane Rockwell as a cottage operation and subsequently moved to a shop in the Laurel Heights neighborhood in 1984 at 512 Presidio Avenue.

The two stores merged to become what is known today as The Delicate Daisy – House of Flowers in 1991 after Roxane Rockwell and Bert Bomersine, Roxane's business partner and husband, purchased House of Flowers from the Miguel Family. In 1992, the newly merged business its operations to the 6040 Geary Boulevard location and closed the original location of The Delicate Daisy at 512 Presidio Avenue.

The Delicate Daisy – House of Flowers maintains a hand-selected, locally-sourced, fresh inventory of flowers for sale in addition to their custom and ready-made floral arrangements and gift baskets for all occasions. Distinctive features of the store include the store's large and carefully arranged and themed window displays and a bright neon sign at the interior reading "the delicate daisy." The Delicate Daisy – House of Flowers' main interior retail area reflects its exterior: brightly-colored, inviting, and familiar.

The Delicate Daisy – House of Flowers has remained a recognized local flower shop and staple in the Richmond neighborhood since 1939. The Delicate Daisy – House of Flowers' customer base primarily hails from San Francisco, but its patrons are still wide-ranging in background, from individual buyers to large companies to other neighborhood stores and restaurants. The Delicate Daisy – House of Flowers maintains a constant stock of fresh, locally-sourced flowers that are hand-selected weekly from the wholesale San Francisco Flower Mart by its staff of professional florists. The Delicate Daisy – House of Flowers also offers custom floral arrangements, gift basket-making, and corsage/boutonniere-making services for any event or occasion including birthdays, graduations, proms, weddings, baby showers, funerals, parties, and large events. The Delicate Daisy – House of Flowers is committed to helping everyone find the flowers and gifts they need, offering highly personalized and customer service and quidance as well as floral expertise.

The Delicate Daisy – House of Flowers has continuously given back to the Richmond community. The store frequently donates flowers and plants to Richmond schools, churches, and businesses. The Delicate Daisy – House of Flowers works closely with the Richmond District Neighborhood Center and Family House organizations, providing flowers and decors for both organization's large events. The Delicate Daisy – House of Flowers is also an active member of the Greater Geary Boulevard Merchants Association.

THE DELICATE DAISY – HOUSE OF FLOWERS Section 4: Written Historical Narrative

CRITERION 1

a. Provide a short history of the business from the date the business opened in San Francisco to the present day, including the ownership history. For businesses with multiple locations, include the history of the original location in San Francisco (including whether it was the business's founding and or headquartered location) and the opening dates and locations of all other locations.

The Delicate Daisy – House of Flowers ("House of Flowers"), located at 6040 Geary Boulevard. in the Richmond District, was founded by Simon Israel as House of Flowers in 1939. Simon purchased the building, lived upstairs where he raised his family, and built a successful flower business. He converted the downstairs garage area into what is still the shop today.

Simon's daughter Ruth and her husband Ron Miguel took over the business in 1966. Like her parents, Ruth and Ron raised their family upstairs and devoted themselves to the shop and betterment of the community. They were the local "go to" florist shop in the Richmond district.

After 25 years, the Miguels were ready to retire, so they sold the shop to Roxane and Bert Bomersine, who owned "The Delicate Daisy" on Presidio Avenue in San Francisco. On November 1, 1991, the ownership of the House of Flowers changed out of the Israel-Miguel family for the first time in 52 years.

Roxane had created The Delicate Daisy in 1982 as a cottage industry in her home in Danville, CA. She had been employed in the property management industry for quite some time and had several business contacts. After a few telephone calls, a very steady weekly business came alive. She would come to the SF Flower Mart every Monday morning to pick up flowers, then design her creative style arrangements in the back of her car, then deliver them to the offices in the San Francisco financial district that had contracted for a weekly floral service. She also designed for weddings, parties, and events out of her home. After a couple of years, it was time to find a small retail location to work out of in San Francisco. In 1984, The Delicate Daisy became an official retail flower shop on Presidio Avenue in the city. Also at that time, her husband Bert Bomersine became her business partner.

For the first six months after purchasing the House of Flowers, Roxane and Bert operated the two retail shops. She was at one shop and he the other. It became evident that the House of Flowers was a very busy store, and both of them needed to be there to maintain the efficiency and excellence for which the store was known. It was then that the decision was made to close the shop on Presidio Avenue after 8 years and blend the two businesses together as one at the Geary Boulevard location.

Together, the Bomersines continued to build the business and excel in all aspects of the floral industry. In 2006, Bert passed away suddenly and Roxane has been continuing to maintain the stellar reputation the House of Flowers has earned since 1939.

b. Describe any circumstances that required the business to cease operations in San Francisco for more than six months?

The Delicate Daisy – House of Flowers has never ceased operations for any period of time in San Francisco.

c. Is the business a family-owned business? If so, give the generational history of the business.

The Delicate Daisy – House of Flowers is a family-owned business. House of Flowers was founded by Simon Israel in 1939 and taken over by his daughter and her husband Ruth and Ron Miguel in 1966. In 1991, the business was sold to spouses Roxane and Bert Bomersine. Roxane is currently the sole owner of the business.

The Delicate Daisy was founded by Roxane Rockwell in 1982. In 1984, her husband Bert Bomersine became her partner until his death in 2006. Roxane is currently the sole owner of the business.

d. Describe the ownership history when the business ownership is not the original owner or a family-owned business.

The ownership history of The Delicate Daisy – House of Flowers is as follows:

1939 to 1966: Simon Israel

1966 to 1991: Ruth Miguel and Ron Miguel

2006 to Present: Roxane Rockwell

The House of Flowers has been an integral part of the Richmond district since 1939. The shop has been supportive of all the schools in the area, donating to many of their fundraisers and providing flowers when needed.

Over the years, The Delicate Daisy – House of Flowers has also established an excellent portfolio of corporate clients. The House of Flowers has provided weekly flowers to the Cliff House for over 45 years. As demonstrated by the closure of the Cliff House on December 31, 2020, the community within the Richmond district is an ever changing one. House of Flowers has customers that have been loyal to the business for 40+ years and those who have recently moved into the neighborhood and just discovered the company.

The Delicate Daisy – House of Flowers takes pride in their customer service and personal attention to detail. Customers love and appreciate the fact that the business goes above and beyond for them. The House of Flowers is so honored to be associated with the late Ron Miguel. He set the standards high for the business and was always the perfect role model. Ron was very active on many advisory committees and neighborhood groups throughout the years. He was a member of the Planning Association for the Richmond District and was head of the San Francisco Planning Commission for five years, just to name a few of his accomplishments. San Francisco has lost a great advocate for the betterment of our local communities, and the House of Flowers has lost a very dear friend.

b. Is the business (or has been) associated with significant events in the neighborhood, the city, or the business industry?

Prom season is a big time at the House of Flowers, as the business creates beautiful corsages and boutonnieres for the students going to the dances. When Roxane and Bert Bomersine first bought the shop in 1991, several longtime customers brought in their "preserved" corsages and boutonnieres in the original boxes to show the new owners.

In addition to prom flowers, many generations of families have come through the doors for their, birthdays, graduations, bar/bat mitzvahs, weddings, baby showers, sympathy, parties, and events, as well as "just because" flowers just because of the joy they bring to people's lives.

e. How does the business demonstrate its commitment to the community?

Roxane gives back to the local community on a regular basis. Donations of flowers, plants, and money are given to all the local schools and churches in the neighborhood when asked for. She also works with the Richmond District Neighborhood Center, providing flowers or plants for events and raffles. She has worked closely with Family House for 35+ years, providing the floral decor for their annual gala event and other activities they sponsor. She was the Coordinator of Florists for Daffodil Days, sponsored by the American Cancer Society for many years.

The Delicate Daisy – House of Flowers is a member of the Greater Geary Boulevard Merchants Association. Roxane attends the merchant meetings and always donates flowers to be given to the honorees.

f. Provide a description of the community the business serves.

The community of customers at The Delicate Daisy – House of Flowers is a melting pot of people throughout San Francisco and beyond. Customers are young and old, including generations from many families that have been customers for 50+ years. While the majority of customers are in San Francisco, there are many that live out of town or even out of state. They patronize The Delicate Daisy – House of Flowers because of its stellar reputation.

Roxane has also worked very hard over the years to maintain a prestigious portfolio of corporate clients. The Delicate Daisy – House of Flowers has worked with Cushman Wakefield, Hudson Pacific Properties, The Hearst Corporation, Jamestown Urban Management at Levi's Plaza and the Waterfront Property, Jones Lang LaSalle, The Shorenstein Company, and the San Francisco Ballet just to name a few. House of Flowers has also worked extensively with the San Francisco Giants, The Golden State Warriors, and the Oakland A's.

g. Is the business associated with a culturally significant building/structure/site/object/interior?

The building that has been home for the House of Flowers is the same exact design today as it was in 1939. There have been no architectural changes, just a few coats of paint over the years. A quaint Victorian style building on Geary Blvd. at 25th Avenue will hopefully forever be recognized as the House of Flowers.

The building that has been home for the House of Flowers is the same exact design today as it was in 1939. There have been no architectural changes, just a few coats of paint over the years. Upon entering the shop, customers walk into an oasis of color and fragrance. It is a true retreat from all the commotion going on outside. The color pallet of watermelon pink, Caribbean blue, outrageous orange, and citrus chartreuse keep customers coming in just to "feel good." The original cedar wood panels are still on the walls and ceiling of the shop. The front windows are always decorated to the hilt representing whatever holiday or season it is. The local neighbors love the display windows! Unfortunately, the sign on the side of the building has been damaged from weather and age and will need replacing. Despite that, the quirky and quaint Victorian-style building on Geary Boulevard at 25th Avenue will hopefully forever be recognized as the House of Flowers.

h. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

The House of Flowers is a landmark in the Richmond district. It is a fixture in the neighborhood that so many people have come to take for granted and assume will always be there. The business got telephone calls from local customers just checking in on the business during the challenging pandemic year, wanting to be sure the business is still here. The Richmond district without The Delicate Daisy – House of Flowers would be like a piece of pie without the ala mode!

The Delicate Daisy – House of Flowers is a retail flower and gift shop selling flowers, flower arrangements, and gift baskets located at 6040 Geary Boulevard. The Delicate Daisy – House of Flowers has roots in two different San Francisco flower shops, House of Flowers, and The Delicate Daisy. House of Flowers was founded in 1939 by Simon Israel and The Delicate Daisy in 1982 by Roxane Rockwell. The two stores merged to become what is known today as The Delicate Daisy - House of Flowers in 1991, after House of Flowers was purchased by Roxane Rockwell from the Miguel Family, Simon Israel's daughter and son-in-law. The Delicate Daisy – House of Flowers maintains a hand-selected, locally-sourced, fresh inventory of flowers for sale in addition to their custom and ready-made floral arrangements and gift baskets for all occasions. The Delicate Daisy – House of Flowers has been owned and operated by Roxane Rockwell since 1991.

The Delicate Daisy first began as a cottage operation run by Roxane Rockwell in 1982 and subsequently moved to a shop in the Laurel Heights neighborhood at 512 Presidio Avenue in 1984, where it remained until 1992. House of Flowers was founded in 1939 by Simon Israel in the Richmond neighborhood at 6040 Geary Boulevard, where

is remains today. In 1991, House of Flowers was purchased by Roxane Rockwell and Bert Bomersine, Roxane's business partner and husband, from Simon Israel's daughter and son-in-law, Ruth and Ron Miguel. In 1992 the newly merged business, The Delicate Daisy – House of Flowers, consolidated its operations to the 6040 Geary Boulevard location and closed the original location of The Delicate Daisy at 512 Presidio Avenue. Distinctive features of The Delicate Daisy – House of Flowers' store include the store's large and carefully arranged and themed window displays, and a bright neon sign at the interior reading "the delicate daisy". The Delicate Daisy – House of Flowers' main interior retail area reflects its exterior: brightly-colored, inviting, and familiar.

The Delicate Daisy – House of Flowers has remained a recognized local flower shop and staple in the Richmond neighborhood since 1939. The Delicate Daisy – House of Flowers' customer base primarily hails from San Francisco, but its patrons are still wide-ranging in background, from individual buyers to large companies to other neighborhood stores and restaurants. The Delicate Daisy – House of Flowers maintains a constant stock of fresh, locally-sourced flowers that are hand-selected weekly from the wholesale San Francisco Flower Mart by its staff of professional florists. The Delicate Daisy – House of Flowers also offers custom floral arrangement, gift basket-making, and corsage/boutonniere-making services for any event or occasion including birthdays, graduations, proms, weddings, baby showers, funerals, parties, and large events. The Delicate Daisy – House of Flowers is committed to helping everyone find the flowers and gifts they need, offering highly personalized and customer service and guidance as well as floral expertise.

The Delicate Daisy – House of Flowers has continuously given back to the Richmond community. The store frequently donates flowers and plants to Richmond schools, churches, and businesses. The Delicate Daisy – House of Flowers works closely with the Richmond District Neighborhood Center and Family House organizations, providing flowers and decors for both organization's large events. The Delicate Daisy – House of Flowers is also an active member of the Greater Geary Boulevard Merchants Association.

The business's primary location, 6040 Geary Boulevard, is a Category B (Unknown / Age Eligible) structure on the north side of Geary Boulevard between 24th and 25th Avenues in the Richmond. It is within the Geary Boulevard Neighborhood Commercial (NCD) Zoning District and a 40-X Height and Bulk District.
