The business was started in 1901 when the original founders, Mr. Kindel and Mr. Graham, began a novelty company selling household items and domestic and imported novelty items door to door. The business has developed since its early beginnings and now focuses on selling party supplies ranging from balloons to costumes to popcorn machines.




