Free PPE Available for San Francisco Small Businesses

In partnership with the California Governor's Office of Emergency Services and the California Office of the Small Business Advocate, Mayor London Breed [announced](#) on Monday the large shipment of Personal Protective Equipment (PPE) – hand sanitizers, surgical masks, and face shields – for small businesses. The goal in providing PPE to businesses is to save them the time and expense of procuring PPE, and to help focus and prepare them for continued safe reopening. In collaboration with local Community-Based Organizations (CBOs), a one-month supply of PPE will be distributed to local businesses that are open and/or will reopen soon, while supplies last.

San Francisco small businesses interested in requesting free PPE should review the list of participating CBOs [here](#) and contact your nearest CBO. Businesses can request a 30 day supply of hand sanitizers, surgical masks and face shields. CBO partners will be picking up their shipments of PPE over the next two weeks. Organizations that have received their shipment will have contact information listed and for those organizations where contact information is not yet listed, please check back.

National Preparedness Month

September is National Preparedness Month (NPM) to promote family, community and business disaster planning. This year's theme is "Disasters Don't Wait. Make Your Plan Today." As we continue to cope with COVID-19 and wildfires throughout California, smart planning can help keep your business running or reopen quickly if disaster strikes. Check out the following resources:

SF Department of Building Inspection (DBI) Updates

- *Permit Updates:*
 - For Over-the-Counter Permits Without Plans and Fire-Only Permits, you will need to [pre-register via Eventbrite](#). Tickets are available weekly.
 - For new applications for Over-the-Counter Permits With Plans, you can make an appointment to submit the permit application [here](#).
- *Utility Shutoff Ordinance:* With residents spending more time at home, construction work performed in residential buildings can be much more disruptive for tenants than it would be typically. Building owners planning to conduct construction work in your residential building would need to notify and prepare alternative water and/or utility sources for your tenants if the work is expected to impact their water and/or utility services. The emergency ordinance is in effect through October 31, 2020 and can be extended. For more information, visit www.sfdbi.org/sip.

Census 2020

It's not too late to participate! There are less than 26 days left to do the 2020 Census and we want to make sure that San Franciscans are counted—citizens and immigrants alike. Help everyone get better representation and benefits by making sure you and your family get counted and by encouraging your employees to do the same. Every person counted brings \$20,000 in federal resources for essential programs and services over the next 10 years. Being counted ensures our fair political representation and more important, confirms that you are here and are part of America. LISC Small Business Relief Grant – Ends September 7, 2020

LISC has been providing grants to small businesses, to help them keep functioning and remain vital facets of their local economies through this challenging period. Five rounds of the grant applications have closed and Round 6 has reopened on August 31, 2020. Applications must be submitted by Monday, September 7, 2020 at 11:59 PM ET. Economic Injury Disaster Loan (EIDL)

Authorized by the stimulus packages, the Small Business Administration (SBA), through Economic Injury Disaster Loans, is offering loan assistance for small businesses and nonprofits. Although the EIDL Advance Funding is no longer available, SBA will still be accepting [EIDL applications](#) to qualified small businesses.

Red Backpack Fund – Reopening on September 8, 2020

Previously shared in our newsletter, the Red Backpack Fund, an initiative started by The Spanx, will be making at least 1,000 grants of \$5,000 each to female entrepreneurs in the U.S. to help alleviate the immediate needs and support long-term recovery of those impacted by this crisis.
